

Instructions to Print Your "Active" License Verification from eLicense.Ohio.gov

The Ohio Speech and Hearing Professionals Board discontinued issuing the license pocket card in 2017. If you need to submit proof of your license status, please follow the instructions below to print a copy of your license verification. Verification of your license is now obtained via the eLicense Ohio License Look-up page accessible by clicking the following link: https://elicense.ohio.gov/oh_verifylicense.

1. Start by entering your first/last name and select the Ohio Speech and Hearing Professionals Board from the dropdown menu:
