# Licensure Renewal Update - Renewal Deadline Approaching July 1, 2021



### For Audiologists, Speech-Language Pathologists, Aides, Hearing Aid Dealers, and Hearing Aid Fitters

House Bill 404 was signed by Governor Mike DeWine on November 23, 2020. Please note the following provisions related to the license renewal extension due to the COVID-19 emergency. Additional information may be found on the Board's license renewal page at <a href="www.shp.ohio.gov/renewal">www.shp.ohio.gov/renewal</a>. If you have already renewed your license and completed your required continuing education hours for the 2019-2020 practice period, no further action is required on your part, and your license will remain valid until your next renewal on or before December 31, 2022.

- Pursuant to House Bill 404, Ohio Speech and Hearing Professional Board licensees whose licenses will expire during the period of emergency (March 27, 2020 April 1, 2021) now have until July 1, 2021 to renew their license and complete any required continuing education hours for the 2019-2020 practice period.
- If you have already renewed your license and completed your required continuing education hours, no further action is required on your part, and your license will remain valid until your next renewal on or before December 31, 2022.
- If you renew your license between January 1, 2021 and July 1, 2021, your next renewal expiration will remain on or before December 31, 2022.

If you renew after December 31, 2020 and need the extension until July 1, 2021 to complete your required hours of continuing education for the 2019-2020 practice period, any continuing education you complete during the extension period for the 2019-2020 practice period will only be counted towards the 2019-2020 renewal cycle. Thus, you will have less time to complete your continuing education hours for the 2021-2022 renewal. If you completed all of the required continuing education hours for the 2019-2020 practice period between January 1, 2019 through December 31, 2020 and renew your license during the extension period, any hours you complete after January 1, 2021 will be counted towards meeting your continuing education requirements for the 2021-2022 practice period.

# Ohio Attorney General Dave Yost Issues Consumer Alert on Over-the-Counter Hearing Aids

On May 3, 2021, Ohio Attorney General Dave Yost issued a press release warning consumers about companies that claim to offer over-the-counter hearing aids. The Board would like to reiterate Attorney General Yost's alert and ask licensees who dispense hearing aids to help raise awareness for consumers. As Attorney General



Yost noted, it is important that consumers are aware of some misleading tactics by over-the-counter hearing aid companies that make false claims of performance, and claims that their over-the-counter devices have the government's approval. Although Congress authorized the sale of over-the-counter (OTC) hearing aids in 2017, currently there are no such products that have the approval of the U.S. Food and Drug Administration. As Attorney General Yost noted, this has not stopped some companies from making false claims that they have been FDA-approved.

As we celebrate May as Better Hearing and Speech Month, it is important to raise awareness that when consumers are considering the purchase of hearing aids, that a licensed audiologist or hearing aid specialist are licensed and qualified to test, select, program, and fit the hearing aid for the consumer. The FDA has not approved ANY OTC hearing aids at this time but is expected to announce proposed rules later this year. The licensure board will continue to provide updates. ## Important Reminder About FDA Red Flags

The Board would like to remind practitioners about the importance of the U.S. Food and Drug Administration's (FDA) Reg Flags as it relates to the sale of hearing aids to consumers. The FDA Reg Flags are a series of medical conditions that, when revealed during the testing and evaluation, should prompt a medical referral.

The FDA has identified the following as Red Flags:

- 1. Visible congenital or traumatic deformity of the ear
- 2. Active drainage from the ear in the past 90 days
- 3. Sudden hearing loss within the past 90 day
- 4. Reported acute or chronic dizziness
- 5. Unilateral hearing loss of sudden or recent onset within 90 days
- 6. Air-bone gap greater than 15dB at 500, 1 & 2k
- 7. Reported pain or discomfort
- 8. Excessive cerumen or foreign body in the ear

When any of these Red Flags occur, the patient/client should be referred on to a physician for medical clearance.

# **Spring Graduates - Important Reminders**

The Board would like to congratulate everyone who is graduating this spring from their audiology and speech-language pathology graduate programs. We would like to remind all graduates planning to practice in Ohio to submit your licensure applications at least a few weeks prior to graduation in order to allow enough time to process your application. The Board has an online application process through the



Ohio eLicense license management system. The online application is available at the following link: https://shp.ohio.gov/elicenseohiogov. For individuals applying for their conditional speech-language pathology license, this is a reminder that the Plan for supervised professional experience is due within thirty calendar days of your start date of employment. The SPE Plan and other forms for the supervised professional experience may be downloaded from the board's website at: https://shp.ohio.gov/forms. # Important Reminder - Supervised Professional Experience Report and Contact Log

The Board would like to remind supervised professional experience supervisors that supervision of the conditional licensee must continue after the Report and Contacts log is submitted to the board office. Ohio Administrative Code sections 4753-3-07 (D)(2) and (G)(2) state in relevant part:

- (D) Supervisor qualifications and responsibilities.
- (2) The supervisor shall agree to supervise the practice of speech-language pathology or audiology experience of the applicant according to a plan approved by the board.
- (G) Supervised professional experience report and supervision contacts log.
- (G)(2) After submission of the "Supervised Professional Experience Report" and "Supervision Contacts Log," the conditional licensee shall abide by the requirements for conditional licensure until full licensure is granted.

When the conditional licensee and professional experience year supervisor have signed the Report and Contacts Log, the conditional licensee must submit the document within thirty calendar days of completion of the professional experience. The professional experience year supervisor shall continue to supervise the conditional licensee until the Board approves the Report and Contacts Log and issues the conditional licensee their speech-language pathology license. Supervisors should check with the conditional licensee to verify timely submission of the Report and Contacts log. The status of the conditional licensees license should be verified from the eLicense Ohio website, license look-up page at: https://shp.ohio.gov/license-lookup. # **ODE Pupil Service License - HB 442**

House Bill 442 amended Section 3319.221 of the Ohio Revised Code to create a new option for individuals who hold a professional license as a speech-language pathologist, audiologist, registered nurse holding a bachelor's degree in nursing, physical therapists, occupational therapists, physical therapy assistants, occupational therapy assistants, and social workers. These individuals will be able to apply,



through the CORE licensing system, for a registration to allow them to serve in their given occupation on either a full time or substitute basis, without the need to hold the previously available pupil services license. The registration will cost \$150.00 dollars and be valid for five years. It will require validation of the professional license, and a transcript showing the appropriate degree for school nurses only, as well as our required background checks. After five years, they will only require validation of continuing to hold the required professional license and background checks to renew, there are no other renewal requirements. The bill went into effect on April 7, 2021 and the Ohio Department of Education's Department of Educator License has information about the new registrations posted on their website at: http://education.ohio.gov/Topics/Teaching/Licensure/Apply-for-Certificate-License/Pupil-Services-Licenses.

It very important to understand that the Pupil Services License is not going away and practitioners who hold their pupil service license can continue to renew it or switch to the registration. The fee for the Pupil Services License is \$200.00. Each applicant is going to need to make their own decision as to whether or not to renew the pupil service license or switch to the pupil service registration depending on their needs. The Board urges licensees to check with their school district or educational service center to verify whether they will continue to require that related service personnel hold the pupil service license or will accept the registration as a condition of employment.

The Board has been informed that the Department of Education is forming a cross-agency team to address questions that have arisen about registration and how to provide training to those who are pursuing registration and do not have a school background or training. ### **Board Appoints Steven Griffin to Ohio Dyslexia Committee**

The Board is pleased to announce the appointment of Steven Griffin, M.A., CCC-SLP, to the Ohio Dyslexia Committee. The Ohio Dyslexia Committee was created after passage of House Bill 436 at the end of last year. Pursuant to the new law, the licensure board is charged with determining its selection process for the appointment of one speech-language pathologist to serve on the committee, along with ten other individuals. At its meeting on January 27, 2021, the Board determined as its selection process for the appointment, to appoint a qualified speech-language pathologist serving on the licensure board. We are honored to appoint Mr. Griffin to the committee. Mr. Griffin brings a wealth of knowledge and expertise in the areas of universal screening, intervention, and remediation for children with dyslexia and children displaying dyslexic characteristics and tendencies. Not later than December 31, 2021, the Ohio Dyslexia Committee shall develop a guidebook regarding the best practices and methods for universal screening, intervention, and remediation for children with dyslexia or children displaying dyslexic characteristics and tendencies using a multi-sensory structured literacy program.

### Rep. Andrea White introduces HB 252 - ASLP-IC

On April 12, 2021, Reps. Andrea White (House District 41, Kettering) and Phil Plummer (House District 40, Dayton) co-sponsored House Bill 252, authorizing Ohio to enter into the Audiology and Speech-Language Pathology Interstate Compact, commonly referred to as the ASLP-IC. The bill was referred to the House Health committee on April 14, 2021, and after sponsor's testimony and a first hearing on April 27, 2021, passed unanimously out of committee. On May 6, 2021, the House unanimously passed (96-0) HB 252. The bill will be referred for consideration by the Senate Health Committee and is expected for consideration by the full Senate by the end of June. If passed by the General Assembly, Ohio will join at least ten other states that have already passed the ASLP-IC. Those states include Alabama, Kansas, Kentucky, Louisiana, Nebraska, North Carolina, Oklahoma, Utah, West Virginia, and Wyoming. With at least ten states having approved the ASLP-IC, the interstate compact is officially activated. The licensure board has served on the ASLP-IC advisory group since 2018 and supports the ASLP-IC as an effective way for consumers to receive appropriate and competent speech-language pathology and audiology services by practitioners across state lines. The compact would permit audiologists and speech-language pathologists to provide services to populations currently underserved or geographically isolated. The compact also would allow military personnel and spouses to more easily maintain their professional license when relocating. The ASLP-IC ensures the ethical and legal provision of services and reduces regulatory barriers while still protecting the public.

# **Board Reminds Practitioners of Duty to Report**

The Board would like to remind practitioners of their duty to report direct, first-hand knowledge, of violations under Ohio Revised and Administrative Code sections 4744, 4747 and 4753. All licensees practice under a Code of Ethics. For hearing aid dealers, fitters, and trainees, the duty to report is specified under Ohio Administrative Code section 4747-1-23 (B)(10), which states: licensees shall report to the board any violation of the board rules or any breach of the code of ethics that the licensee is aware of. For audiologists, speech-language pathologists, conditional speech-language pathologists, and aides, the duty to report is specified under Ohio Administrative Code section 4753-9-01 (B)(10), which also states: licensees shall report to the board any violation of the board rules or any breach of the code of ethics that the licensee is aware of. Licensees have a duty and responsibility to report known violations of the practice act and breach of the code of ethics. Licensees can report violations by submitting a complaint on the eLicense Ohio website: File a Complaint—Duty to Report. You may also contact the Board office and request to speak with the Executive Director, Gregg Thornton, if you have questions about whether a situation should be reported. The Duty to Report requirement is an important component to a practitioner's responsibility under their license, as well as ensuring consumer protection.

The Board received comments during the public comment period between March 12, 2021 through April 16, 2021. The Rules Committee met on May 6, 2021 and reviewed the comments. The Board will be proposing additional changes to the rules, which will be posted on our website. Another period of public comment will occur from May 15, 2021 through June 15, 2021. # HIPAA Compliance - Considerations When Sending Test Results - Important Reminder

The Health Insurance Portability and Accountability Act (HIPAA) is a federal law that sets forth the requirements and standards for the protection of certain health information. The U.S. Department of Health and Human Services, Office for Civil Rights has responsibility for implementing and enforcing the Privacy Rule with respect to compliance activities and civil monetary penalties. Practitioners must be mindful that when sending patient/client test results or other information protected under HIPAA to another entity, the release of the protected information should only be done with the knowledge and consent of the patient/client. The Board would like to remind licensees that although HIPAA is a federal requirement, licensees can be subject to disciplinary action by the Board for HIPAA violations, such as the unauthorized release of patient/client health information protected by HIPAA. fitting and sale of a hearing aid.

With Ohio's vaccine distribution plan well under way, Ohioans, including businesses, governmental entities, and schools, are implementing responsible restart plans to resume daily activities and services. During the Stay-At-Home order that went into effect from March 23 through May 29, 2020, certain exceptions allowed individuals to leave their residence to work for or obtain essential services. This exception included all individuals licensed under our Board's Ohio Revised and Administrative Code Chapters 4744, 4747, and 4753. The Board received inquiries regarding whether or not in-person testing requirements for the dispending of hearing aids were waived due to Ohio's Stay-At-Home order issued in response to the Coronavirus pandemic (COVID-19). The Board addressed this question in its special edition eNewsletter released in May 2020, clarifying that the measurement and testing of human hearing is a requirement for the

Even though the Stay-At-Home order is lifted and the vaccine is now available to all age groups between sixteen years of age and older, the Board would like to remind licensees that appropriate test procedures must continue to be followed. In Ohio, for an audiologist, the measurement and testing of human hearing by means of an audiometer or by any other means is a requirement for the purpose of selecting, adapting, and selling a hearing aid to any person. Best practice would include an otoscopic examination. For a hearing aid fitter, the rules specifically state the required hearing tests that shall be completed before recommending, selling or fitting of a hearing aid. A screening for hearing loss does not meet the Board's rules/requirements for selecting, adapting, and selling of a hearing aid.

# Ohio Department of Education Issues Telehealth Guidelines For Service Providers

The Ohio Department of Education (ODE) issued telehealth guidelines for service providers, which includes school-based speech-language pathologists and educational audiologists. As ODE noted, "One of Ohio's top priorities is to support the mental health and well-being of all Ohio's students." The Board's school-based practitioners must hold an ODE Pupil Service License in order to deliver appropriate services to students with disabilities. During the spring 2020 ordered school-building closure period as a result of the COVID-19 pandemic, schools remotely supported continued learning and related services virtually when feasible. As schools reopen, whether remote, in-person, or using a hybrid approach, school-based practitioners will face important considerations when providing related services via telehealth to meet students' needs. The Board addresses telehealth communication for audiologists and speech-language pathologists under Ohio Administrative Code Chapter 4753-2. ODE's telehealth guidelines addresses other important considhe erations for school-based practitioners, such as permission forms, telehealth platforms, privacy and confidentiality considerations, to name just a few. ODE has addressed these considerations in the form of FAQs, which the Board urges all school-based practitioners to review at the following link: http://education.ohio.gov/Topics/Reset-and-Restart/Telehealth-Guidelines-for-Service-Providers. You will also find related resources addressing Students with Disabilities Guidance, Additional Considerations for Special Education, and Students with Disabilities Compendium of Resources.

All staff and operations of the licensure board will be available remotely. Licensure applications will continue to be processed and complaints will continue to be investigated. Board staff will be available to answer telephone calls and e-mails during our normal business hours, e.g., Monday-Friday, 8:00 a.m. to 5:00 p.m. Board members are accessible when necessary to assist staff with responding to any questions. ### **Update for Spring and Summer Graduates**

### **ETS - Praxis Exam**

Individuals graduating from the university programs who intend to practice in Ohio should submit their application to the Board approximately 4-6 weeks prior to their graduation date. ETS offers candidates alternative options to take the exam remotely. Applicants who have not yet taken their PRAXIS exam should contact ETS directly for further information.

### **Criminal Background Checks**

The Ohio Attorney General's Office oversees the FBI and BCI criminal background check that is required for initial licensure. Web-check entities, such as police departments, county sheriff's office, and authorized web-check entities are not closed, but operating under reduced hours due to COVID-19. We recommend that applicants visit the Ohio Attorney General's website for information on locating an authorized web-check vendor in their area at:

The Attorney General's Office is recommending that applicants call ahead before traveling to any location to verify they are providing fingerprinting services. Many web-check locations are open but observing limited hours and have specific restrictions in order to adhere to social distancing requirements. If you cannot find a location in your county, you may find better results by calling an authorized web-check entity in a surrounding county.

Until further notice, the Board will process service requests in eLicense for wall certificates and license verification letters electronically. Anyone submitting these requests will receive an e-mail with the item(s) attached


