Message from the Executive Director

Welcome to this edition of the Ohio Speech and Hearing Professional Board's eNewsletter. We appreciate you taking time to review some important licensure board updates. There are some new and significant changes about the laws and rules that

govern licensed hearing aid dealers and hearing aid fitters. For instance, hearing aid dealers and hearing aid fitters will no longer renew their license every year by January 30th. The renewal for these licenses is every two years by December 31st of the even numbered year.

Hearing Screenings in the Schools

Communication is a two-way street in which we need to be able to listen and process what someone says and communicate a response. There are many factors that can impact communication. One of those foundational factors is hearing.

According to Niskar et.al. (1998), research indicates that 14.9%* of US children have low-frequency or high-frequency hearing loss of at least 16 decibels in one or both ears. A school age child's ability to hear influences the development of communication and behavioral skills that affect educational experience and relationships.** Speech-language pathologists and educational audiologists play a pivotal role in ensuring communication happens for ALL students in the schools. Being able to hear clearly is the foundation for effective communication.

In Ohio, threshold testing for hearing loss is under the scope of practice of the audiologist. (Revised Code 4753.01(G)). A speech-language pathologist cannot do threshold testing under the Ohio Revised Code; however, speech language pathologists can conduct hearing screenings under R.C. 4753.01(C) and Ohio Administrative Code Chapter 4753-6. If a student does not pass a hearing screening, the speech-language pathologist shall refer the student to a physician or an audiologist. It is important to note that hearing screenings for students must be done at schools if the board of education or the board of health offers services by a physician or a nurse in the school. The hearing screenings must be done in accordance with the requirements set forth by the Ohio Department of Health.

The following individuals are able to conduct hearing screenings:

- Physicians (Revised Code 3313.68).
- Audiologists (Revised Code 4753.01).
- Audiology aides only under the supervision of an audiologist (Revised Code 4753.072(G)).
- Speech-language pathologists (Revised Code 4753.01(C)).
- Speech-language pathology aides only under the supervision of a speech-language pathologist (Revised Code 4753.072).
- Registered Nurses (Revised Code 3313.68).

ASHA also defines the role of the speech-language pathologist in childhood/school age hearing screenings. Speech-language pathologists play a role in the screening, speech/language/communication assessment, and rehabilitation of individuals with hearing loss and the referral of individuals suspected of having hearing loss to an audiologist as appropriate. See [ASHA's Scope of Practice in Speech-Language Pathology](#) (ASHA, 2016).

The Ohio Revised Code and the Ohio Department of Health have specific requirements for how to conduct hearing screenings and how to ensure that the child is hearing the presented tone. (Refer to the Ohio Department of Health's Hearing Screening Requirements and Guidelines <https://odh.ohio.gov/wps/portal/gov/odh/know-our-programs/children-s-hearing-vision-program/requirements/2015-guidelines>)

- Turn the intensity dial to 50dB at 4000 Hz for a practice tone. If the child responds, you are ready to begin the screening.
- Present the following tones to the right ear: 4000 Hz @ 20dB 2000 Hz @ 20dB 1000 Hz @ 20dB
- Present the following tones to the left ear: 1000 Hz @ 20dB 2000 Hz @ 20dB 4000 Hz @ 20dB
- The screening test is now completed. Record your results.

If a student does not pass a hearing screening at school or cannot be tested, it is critical for the student to be referred to an appropriate professional such as an educational audiologist or audiologist for further testing. Hearing is CRITICAL to speech and language development, communication, and learning. Untreated and undiagnosed hearing loss will not only negatively impact students in the school setting but also in their everyday life.

Licensure Updates - Rule Changes

The Ohio Speech and Hearing Professionals Board (Board) adopted, amended, and rescinded the following rules which became effective on August 12, 2019.

The Board adopted four new rules under Ohio Administrative Code Chapter 4744.

4744-1-01 - Procedure for adoption of rules

4744-1-02 - Method of determining time and place of meetings

4744-1-03 - Personal information systems

4744-1-04 - Duties of officers and staff

These rules were previously under the former licensure boards and deal primarily with requirements the licensure board must follow related to adoption of rules, determining the time and place of meetings, how personal information is maintained, and the duties of officers and staff. These rules are now under Ohio Administrative Code Chapter 4744: <http://codes.ohio.gov/oac/4744>.

The Board adopted two new rules establishing licensure fees and a code of ethics for hearing aid dealers, hearing aid fitters, and trainee permit holders.

4747-1-22 – Licensure Fees

4747-1-23 – Code of Ethics

What does Ohio Administrative Code (OAC) section 4747-1-22 address?

All licensure fees for hearing aid dealers, hearing aid fitters, and trainee permit holders were moved from the Ohio Revised Code to this section under the OAC. There were no fee increases. While most fees remain the same, some fees were reduced. For example, the renewal fee was reduced from \$157 each year to \$120 every two years. The renewal fee tiers were also eliminated, e.g., \$183 for renewal until Mar. 1 and \$210 for renewal after Mar. 1, and replaced with a late fee of \$120 if the license is renewed up to ninety days past the expiration date of December 31st of the even numbered year. The fee for a hearing aid dealer's application was reduced from \$262 to \$200. For the complete list of fees, please visit the Board's website at: <https://shp.ohio.gov/fees>)

What does OAC section 4747-1-23 address? <http://codes.ohio.gov/oac/4747-1-23v1>

The Board adopted a new Code of Ethics for hearing aid dealers, hearing aid fitters, and trainee permit holders in accordance with Ohio Revised Code section [4744.50](http://codes.ohio.gov/oac/4744.50). The Code of Ethics sets forth requirements to ensure the health and welfare of consumers receiving services from individuals and/or entities licensed under Ohio Revised and Administrative Code Chapters 4744 and 4747. The Code of Ethics are part of the hearing aid dealers and fitters practice act and consequently must be followed when providing services. Any violation of the Code of Ethics can be grounds for disciplinary action against the license holder. The Board amended the following five rules under OAC Chapter 4747 for hearing aid dealing and hearing aid fitting.

4747-1-11 - Renewal Procedures

4747-1-12 - Duplicate certificates

4747-1-13 - Sales receipt

4747-1-15 - Fraud and/or misrepresentation, suspension, revocation or refusal of issuance of licenses and trainee permits

4747-1-17 - Licensee responsibilities

What does OAC section 4747-1-11 address? <http://codes.ohio.gov/oac/4747-1-11v1>

- changes license renewal for hearing aid dealers and fitters from annual renewal to biennial renewal. The license expires every two years on December 31st of every even-numbered year. The next renewal deadline for hearing aid dealers and hearing aid fitters is December 31, 2020, and licensees will not need to renew their current license until the license renewal period opens on October 1, 2020.

What does OAC section 4747-1-12 address? <http://codes.ohio.gov/oac/4747-1-12v1>

- requires licensees and permit holders under Chapter 4747 to request duplicate wall certificates via a service request in eLicense.Ohio.gov at no cost.

What does OAC section 4747-1-13 address? <http://codes.ohio.gov/oac/4747-1-13v1>

- sales receipt requirements for hearing aid dealers and hearing aid fitters were rescinded from statute under Ohio Revised Code Chapter 4747 and moved under this board rule. There were no substantive changes to the sales receipt requirement for the sale of hearing aids.

What does OAC section 4747-1-15 address? <http://codes.ohio.gov/oac/4747-1-15v1>

- added reprimand, place on probation, or refusal to issue or renew a license or permit as additional grounds of disciplinary action to the existing grounds for disciplinary action which included suspension or revocation of licenses or permits issued under Chapter 4747.

What does OAC section 4747-1-17 address? <http://codes.ohio.gov/oac/4747-1-17v1>

- requires licensees and permit holders under Chapter 4747 to notify the board in writing of any felony or misdemeanor conviction other than minor traffic violations, within thirty days from the date of conviction.

The Board amended the following five rules under Ohio Administrative Code Chapter 4753 for speech-language pathology and audiology

4753-2-01 - Telehealth communications

4753-3-01 - Application for license

4753-3-03 - Notice of change of address (<http://codes.ohio.gov/oac/4753-3-03v1>)

4753-5-01 - Fees (<http://codes.ohio.gov/oac/4753-5-01v1>)

4753-9-01 - Code of Ethics (<http://codes.ohio.gov/oac/4753-9>)

What does OAC section 4753-2-01 address? <http://codes.ohio.gov/oac/4753-2>

- no substantive changes were made to the telehealth communications rule for speech-language pathology and audiology; the rule required a minor change that substituted references to the former board name, e.g., Ohio Board of Speech-Language Pathology and Audiology with the new board name, e.g., Ohio Speech and Hearing Professionals Board.

What does OAC section 4753-3-01 address? <http://codes.ohio.gov/oac/4753-3-01v1>

- no substantive changes; substituted references to the former board name, e.g., Ohio Board of Speech-Language Pathology and Audiology with the new board name, e.g., Ohio Speech and Hearing Professionals Board.

What does OAC section 4753-3-03 address? <http://codes.ohio.gov/oac/4753-3-03v1>

- requires licensees under Chapter 4753 to update their contact information within thirty days via a service request in eLicense.Ohio.gov at no cost.

What does OAC section 4753-5-01 address? <http://codes.ohio.gov/oac/4753-5-01v1>

- reduces the late fee for licenses issued under Chapter 4753 from \$150.00 to \$120.00; reduces the late renewal period from one year from the date of expiration of license to ninety days; fee to renew an expired license between April 1 through December 31st is \$200, without a late fee or subject to continuing education audit.

What does OAC section 4753-9-01 address? <http://codes.ohio.gov/oac/4753-9>

- amended the Code of Ethics for audiologists, speech-language pathologists, conditional speech-language pathologists and aides in accordance with Ohio Revised Code section [4744.50](#). The Code of Ethics sets forth requirements to ensure the health and welfare of consumers receiving services from individuals licensed under Ohio Revised and Administrative Code Chapters 4744 and 4753. The Code of Ethics are part of the speech-language pathology and audiology and consequently must be followed when providing services. Any violation of the Code of Ethics can be grounds for disciplinary action against the license holder. The Code of Ethics is accessible at the following link: <http://codes.ohio.gov/oac/4753-9>.

Workload Determination Process—An effective resource as the new school year gears up!

The Board has previously reported that the Ohio Department of Education's (ODE) Special Education Operating Standards were amended on July 1, 2014, emphasizing the process for determining the appropriate caseload for all school-based speech-language pathologists and audiologists. The ODE Operating Standards **require** school districts to utilize a workload determination process in order to calculate the practitioner's caseload. **The workload determination process is not optional.**

As the new school year begins, we would like to provide resources and tools to assist our school-based licensees who are having discussions with their school administrators about implementing their workload determination process.

The first resource we would like to provide is the actual ODE rule. Ohio Administrative Code section 3301-51-09(I)(1) states in relevant part the components that are to be factored into determining your caseload.

3301-51-09(I)(1)

(I) Service provider workload determination for delivery of services

School districts, county boards of developmental disabilities and other educational agencies shall determine workload for an individual service provider based upon all of the factors set forth in paragraphs (I)(1) to (I)(3) of this rule.

- (1) Workload for an individual service provider shall be determined by the following process, which incorporates the following components:
 - (a) All areas of service provided to children with and without disabilities, including, but not limited to school duties, staff meetings, professional development, supervisions, travel/transitions, screening, assessment, evaluation, progress documentation and reporting, secondary transition service planning, conference/consultation pertaining to individual students, documentation for individual students, and third party billing requirements.
 - (b) The severity of each eligible child's need, and the level and frequency of services necessary to provide a free and appropriate public education.
 - (c) Time needed for planning in accordance with paragraph (A)(9) of rule 3301-35-05 of the Administrative Code including statutory and/or contractual agreements applicable to the educational agency.

In summary, the rule for the workload determination process is not optional and must be applied for all students who have been qualified to receive special education services. School districts must implement the workload determination process to setting caseload standards that allow speech-language pathologists and educational audiologists to complete the wide range of their professional responsibilities necessary to meet individual student's needs. This process is considered best practice for school speech-language and audiology services, and ensures compliance with IDEIA and other mandates. The maximum caseload numbers under the rules remain unchanged, e.g., 80 for SLPs, 100 for AUDs, and 50 for preschool or students being served with multiple disabilities. It is important to recognize that if your school district is following the workload determination process, you should arrive at an appropriate caseload number for your workload.



The Ohio Department of Education has developed a number of resources available on their website, including guidance and clarification memorandum, FAQs, a workload determination calculator, and even no fewer than ten videos narrated by Dr. Charles Carlin, CCC-SLP, with the University of Akron. The Board would like to remind all licensees about their respective continuing education requirements.



Requirements for Audiologists and Speech-Language Pathologists

Audiologists and speech-language pathologists are required to complete twenty hours of continuing education, including two hours related to ethics pursuant to Ohio Administrative Code section 4753-4-01. At least ten hours of continuing education must be specific to the clinical practice in the area the person is licensed. A licensee is not required to obtain continuing education for the first renewal. Licensed audiologists and speech-language pathologists required to complete continuing education have until December 31, 2020 to complete their hours.

Requirements for Hearing Aid Fitters

Hearing aid fitters are now required to complete twenty hours of continuing education, including two hours related to ethics pursuant to Ohio Administrative Code section 4747-1-11. Continuing education clock hours must be acquired in subjects related to hearing aid fitting or audiology. A licensee is not required to obtain continuing education for the first renewal. Licensed hearing aid fitters required to complete continuing education have until December 31, 2020 to complete their hours.



Will my hearing aid dealers or hearing aid fitters license expire on January 30, 2020?

No, due to new statute and rule changes under Chapters 4747, the license renewal expiration date was changed to December 31, 2020 to align with the expiration date of other license types issued by the board to maximize efficiencies and board operations. The continuing education requirements for hearing aid fitters has changed to 20 clock hours, which includes 2 hours related to ethics and must be completed between January 1, 2019 through December 31,
